

# Brief on the Dave Omokaro Foundation




#### <u>About us</u>

The Dave Omokaro Foundation (DOF) is a registered Non-profit and Private Trust dedicated to capacity building and training of public and private institutions and individuals including the elderly in order to enhance effective response to and management of challenges of ageing with a focus on Policy, legislation program planning and sustainable services delivery for enhanced quality of life (QOL) of older persons in Nigeria and Sub-Saharan Africa. DOF has been in the forefront as a leading ageing organization in Nigeria

Our compelling mission is to become the premier centre on ageing and sustainability in Sub-Saharan Africa and to lead the development of capacities of persons and institutions including government and private institutions, CSOs, NGOs, FBOs, HMOs, the family, community and older persons themselves to understand ageing and issues of older persons, forge innovative strategies to enable informed policy and action in consistence with international Plans of Action and United Nations principles on ageing and older persons.

#### Innovative partnerships

Leveraging the mandate, mission statements and influence of stakeholders to forge national and International Institutional collaboration on issues of Ageing and older person, DOF promotes informed advocacy and research for policy and action.

#### Pioneer of Gerontology Education in Nigerian Universities in Collaboration with NUC

NUC/DOF partnership has yielded the development of Benchmark Statement and Minimum Academic Standard (BMAS) for post graduate studies (PGD, MSc, Ph.D) to be piloted in eleven (11) Nigerian universities (commencing September, 2014) and International Partnerships and Special Initiatives for faculty development in ageing and research:
