
# What is it?



# September 2012

DC Office on Aging Strategic Plan 2013-2017 was published with its 2012 Older Adult Needs Assessment woven into the World Health Organization Age-Friendly City Domains.







## October 2012

DC Mayor Vincent C. Gray announced that DC will be seeking WHO Age-Friendly City status.

# May 2013

Mayor Gray holds DC Age-Friendly City Symposium with 500 participating electronically in a community conversation about how DC's age friendliness is perceived and vote on possible ways to improve.



# October 2012

DC Office on Aging was authorized to create a new position: Age-Friendly DC Coordinator

I (Gail Kohn) was hired in May 2013 to fill that role because of my previous experience , particularly with the DC village movement.

# July 2013

New York Academy of Medicine report analyzing the 2012 DC Older Adult Needs Assessment and the results of the Mayor's DC Age-Friendly City Symposium, noting from which groups additional Community Conversations were needed and by WHO domain, where improvements in age friendliness were recommended.

New York Academy of Medicine trained facilitators and scribes for consistent collection of additional information from DC Community Conversations.



## September 2013

Mayor Gray delivered a progress report to 250 participants and announced the DC Age-Friendly Task Force membership.



# August 2013 – May 2014

Groups met (total of more than 3,700 DC and discussed the domain-specific directions. Homebound were surveyed.





## December 2014

The departing Mayor presented the 2014 Age-Friendly DC Strategic Plan.



## Domain 1: Outdoor Spaces and Buildings

Goal 1.1: Increase access to and utilization of parks, open spaces and public buildings.







### **Domain #2: Transportation**

Goal 2.1: Ensure all modes of transportation are safe, affordable and accessible for residents of all ages and abilities, particularly older adults.

Goal 2.2: Provide residents with the information and tools they need to make informed travel choices.







### **Domain #3: Housing**

Goal 3.1: Streamline, expand, and promote programs that support affordable housing and aging in place.

Goal 3.2: Maximize awareness and provide training to increase the amount of housing that is accessible, affordable and healthy.



# World Health Organization Kobe Project

- DC was selected to pilot Age-Friendly City Indicators
- One of 15 other cities across the world; met in Geneva in June
- Observations from participating:
  --Age-Friendly DC was recognized for engaging DC residents (particularly homebound), its 2 additional domains and integrating other DC plans and DC government agencies in its implementation strategies




